I could not get home fast enough to start my next design.



"Unseen Hands" is a name I chose a long time ago for the name of my business. Ironically, the name truly fits this adventure I am taking. It feels like I am being guided by Unseen Hands every day that I move closer to my goals. How blessed am I...

# Quilt Show Update

Our quilt show meetings are generating a lot of ideas, and the show is starting to take shape. We always need more help. There are still a few positions that need someone to head them up. White Glove/Security needs someone to oversee volunteers, and we need a person or persons to oversee the show set-up and take-down. Carolyn Lundie said she would be happy to share her expertise.



The auction needs items, so I hope you are working on something to contribute. We will have an auction on Saturday and one on Sunday. Dividing the items and having two auctions will take less time away from vendors each day. The deadline for the **auction item form** and **a picture** is the April meeting, **APRIL 12, 2018.** Betty Putzka will be accepting the forms and pictures.

When you donate a finished item for the auction, you can request up to 30% of the sale price be returned to you. That information is needed on the form. After the auction you will receive a receipt showing the amount that your donated item sold for, and you can use it as a deduction on your taxes.

Unfinished and small items will be sold in a small boutique area. We plan on having a scrap bag where you can fill a bag with scraps for a small fee. Please save your scraps to put in the scrap bag. I will collect those at each guild meeting. I know that I am going to purge all of the scraps that I have been hoarding thinking I will make something out of them. I finally decided that I was just kidding myself, so am donating them to a good cause. Unfinished items will be donations only, and no percentage will be returned to you when the item is sold in the boutique.

The guild is needy, so we are also asking for items for raffle baskets. Maybe your circle could put together items for a basket. Peggy Campbell will be handling the basket/door prize position this year.



Also, please consider putting a quilt, wall hanging, table runner or some item you have made into the show. I will confess that I have never entered anything. I will this year. Other people tell me that it is thrilling to see their item up on one of the racks, and friends and relatives are excited to look for your item and more likely to come to the show. There is no charge to have your quilt judged. The feedback is always positive.

Just remember, we all started as total beginners and are always taking classes, talking to other quilters and enjoying our teachers to get better. No one is perfect. Although I do have to admit that several of our members are pretty close, most of us are ordinary quilters and enjoy the quilting process and interaction with other people that like to quilt.

The minutes of the November Board meeting were approved as presented in the December newsletter. It was moved by Sherry Delano and seconded by Kathy Greene.

1<sup>st</sup> VP Co-Chair Kathy Greene reported that the workshop taught by Mary Tabar was a fun day. Trinity Community Church seems to be okay with the guild using their facility. Our Feb. speaker will be Erica Plank, March – Linda Rasmussen, April-Tiffany Hayes, May-Katsy Chappell. The workshop for April must be rescheduled as it is a conflict with both SCCQG's 'Meet the Teacher' and the Spring Retreat. It was moved by Kathy Greene and seconded by Jamie Harrington that those guild members who host speakers in their homes will take the workshop for free. Donna Roberts will be refunded her workshop fee. It was suggested that this needs to be presented to the guild as a standing rule and voted on by the membership.

**Publicity Jamie Harrington** stated that Quilter's Path is discontinuing their publication. She wants to advertise guild meetings and the quilt show in Quilter's Companion. We must pay for 2 years for \$195 plus \$30 for the web site ad. No decision was made regarding this.

Kathy Greene and Peggy Vachon are going to check and see if they have an AV screen which could be donated to the guild.

## Tip of the Month

## Helpful hints for entering a JURIED QUILT SHOW

Important information: Be sure to observe all deadlines.

Quilts submitted after the deadlines are usually dismissed out of hand, regardless of how beautiful your quilt is. Be sure to follow any instructions about submission for a particular category or group. Read the rules and regulations carefully and follow them.

Follow the rules for the type of photographs required.

The rules for the quilt show are set by the hosting organization and will change from show to show.

Judges all adhere to similar standards of judging, although final results will be varied based on the individuals. Quilts are judged individually, then against other quilts in their category and classifications. Best of show quilts are the most perfect quilts with the best workmanship and design elements in the show.

What is important to remember is that having your quilts judged is to improve your techniques for the next quilt, to learn from the judge's comments. **Do not take comments personally, but use them as a springboard for improving your workmanship.** 

What criteria are used for JUDGING A QUILT? Design / Technique/ Workmanship / Presentation

Presentation: Many beautiful quilts have been knocked out of completion because of pet hair, lint, stains, and odors. Be sure all threads are buried and none are left dangling from construction. All marking should be removed. BE SURE YOUR QUILT IS IMPECCABLY CLEAN.

#### WORKMANSHIP:

Technique: For the most part, like quilts are judged against each other in their respective categories. It is important to read the rules carefully and enter your quilt in the correct category. Whichever technique you chose, it should the best workmanship that you can achieve. Again, no dangling threads, applique should be well stitched with invisible stitches. Pieced blocks should have points not cut off or into the seam allowance.

Pay attention to the basics of construction and do the absolute best that you can.

Overall look of the quilt and the impact it has on viewers is important.

Does it hang straight? Are the edges straight and plumb?

Does the quilt lie flat? Do the borders wave?

Precision of seam allowance is examined.

Are points cut off or are they lost into seam allowance?

Are threads not buried but hanging off the quilt?

Quilting details, regardless of what type of quilting (hand, domestic or long-arm). Is a consistent type of quilting being used? Are the stitches even, standard in size and shape? Was the quilting by an individual, a group or professional long arm quilter. (Credit must be given to whoever did the quilting.)

Machine quilting (domestic or long arm) is examined for correct tension, thread dots on back of quilt. They look for the starts and stops and the expertise of the backtracks. Thread nests are especially frowned upon.

The binding is especially important. Are there threads hanging, missed stitches, gaps in the stitching? Are there any parts where the binding is empty or weak? Are the corners sewn closed on top and bottom? Is the size of the binding uniform; is there any pulling to the back to cover the stitches attaching the binding? Stitches that attach the binding to the quilt should not be seen, but covered by the binding. No batting should be poking through.

### 2018 AVQA QUILT SHOW ENTRY RULES & JUDGING GUIDELINES

1. AVQA MEMBERS current as of January 1, 2018 may enter quilts for judging or exhibition only. AVQA MEMBERS who join after January 1, 2018 may enter quilts for exhibition only.

2. Quilts judged in previous AVQA shows cannot be entered again except by invitation or exhibition only.

- 3. Entrant must be the maker of the entry to be judged.
- 4. Multiple entries by the same entrant will be hung as space permits.

5. Each quilt entry requires a separate entry form with a photograph attached. The photograph may be of a quilt in progress (unfinished). Photo can be taken at the April meeting during the break.

6. DEADLINE FOR REGISTRATION IS THURSDAY, APRIL 12th. Entry forms will be published in the newsletter and electronic forms will be on the AVQA website. Forms will also be available at Guild meetings. **WE NEED YOUR ENTRY FORMS BY APRIL 12TH**.

7. Quilts must be finished, clean, and free of odors and pet hair.

8. A four-inch sleeve is required on all quilts except small quilts. Quilts wider than 110 inches cannot be hung on AVQA quilt stands unless folded and draped over the rod.

9. All quilts should have a cloth label sewn on the back. The entrant's name and the quilt's name should be included. Names on the quilts will be covered during judging.

10. Quilts that are to be judged must be delivered to the Lancaster United Methodist Church, 918 West Avenue J, Lancaster on Thursday, May 17, between the hours of 8:00 a.m. and 10:00 a.m. <u>only</u>. Exhibit Only quilts **may** be delivered during that time or to the Antelope Valley Fair Grounds Friday, May 18, between 10:00 a.m. and 2:00 p.m. Receipts will be provided with each entry. Alternate check-in arrangements may be made by contacting Sue Jacobsen.

11. The facility will be closed during the "take down" process of the show to all except to those who are working.

12. Quilts may be picked up at the checkout station between 5:00 p.m. and 6:00 p.m. on Sunday, May 20. BRING YOUR RECEIPT. For security purposes, entries may only be removed from the facility through the checkout station.

## JUDGED QUILTS

GUIDELINES: Judges reserve the right to move, split, or combine categories dependent on number of entries received.

PIECED QUILT: A quilt is considered to be pieced if the piecing is predominant over all other techniques.

APPLIQUED QUILT: A quilt is considered to be machine appliqued if both machine and hand applique techniques are used. A quilt is considered to be hand appliqued when ALL of the applique work is done by hand.

MIXED TECHNIQUES QUILT: A combination of appliqué and piecing techniques are used to form the quilt top. Both techniques must contribute to the over-all design. The quilt must contain a noticeable & significant amount of both.

GROUP QUILT: A quilt with a top that has been constructed by two or more people. Examples of this type of quilt are round robin, block exchange, or a quilt made by a friendship circle.

SPECIALTY TECHNIQUES: Machine or hand quilted entries using predominantly specialty techniques such as cross stitch, embroidery including redwork, stenciling, painting, trapunto, whole cloth, crazy quilting, cathedral window, yo-yo, and rag quilts. This includes quilts that do not fit into the Applique or Pieced categories, and include quilts made using innovative techniques of construction, design and embellishment such as used in pictorial quilts, abstract quilts, Snippets, and quilts of original design using innovative piecing or applique techniques.

WEARABLE ART/OTHER Wearable Art: the piece must be intended to be worn as a garment or fashion accessory, i.e., hat, belt, purse, vest, scarf. The item must contain recognizable quilting. Other: this can include quilted items such as pillows, placemats, table runners, dolls and other stitched toys, tree skirts, Christmas stockings, sewing machine covers, and tea cozies.

FIRST TIME ENTRANT: This is the first time the member has entered a quilt for judging in an AVQA quilt show.
