### Babylock Jazz II Sewing and Quilting Machine

Al's Vacuum and Sewing in Lancaster has donated a Babylock Jazz II Sewing and Quilting Machine to AVQA.

This machine has 12" Workspace, 28 Built-In Stiches with Stretch Stitch Capabilities, 1000 Stitches per minute, programable needle up/down, hands free pressure foot, 9 feet included, automatic needle threader, and automatic bobbin winder, just to name a few of the features.
