Approval for minutes for March meeting as printed in the April newsletter was moved by Lynn Aguirre 1<sup>st</sup>, Sue Jacobsen 2nd. Approved with 3 oppositions

regarding a motion made by Pat Crook but was not worded correctly.

Approval of Treasurer's Report for March as printed in the April newsletter was moved by Nette Louton 1<sup>st</sup>, Jamie Harrington 2nd. Approved.

#### President's Message/Kathy Greene

Thank you to everyone attending. Tonight, we have Trudy Cleveland. The business meeting will be after the speaker.

#### 1<sup>st</sup> VP Programs/Nette Louton

Next month we have Jane Hauprich. She will talk about how to do quilting. We are scheduled for a

sew-in on Saturday. Nette will not be there; she will be at Meet the Teachers. It will be via Zoom, starting at 9am.

#### 2<sup>nd</sup> VP Quilt Show/Jamie Harrington

She has 3 potential vendors who wanted to be at this year's quilt show. She sent them applications for next year's show. She has the Jazz2 tickets now. If you want some, let her know. She will arrange for you to purchase them.

#### **Secretary/Corinne Gurney**

UFO Challenge – The new number drawn is 8. These will be due by the May meeting.

#### Parliamentarian/Sandy Smith

Elections were to be held at this meeting, but it was decided to wait until next month to vote.

She requested nominations from the floor. The following actions occurred:

President – Lynell Rodeo was nominated & 2<sup>nd</sup>. She will think about it.

 $1^{\text{st}}$  VP -Peggy Campbell was nominated. She will think about it.

 $2^{nd}$  VP – Jamie Harrington has already accepted the position.

Treasurer – Stephanie Shuping has already accepted the position.

Secretary - Corinne Gurney may stay on.

Parliamentarian – Sandy Smith may stay on.

Next discussion was regarding the motion made last month by Pat Crook. Her proposed change to the standing rule is to be "Members who receive the newsletter via US Mail shall pay \$10.00 to cover cost of printing and postage. Sandy researched that this may violate the by-law that states that all members are to receive a newsletter when they pay their dues. The by-laws say they can get either way. Per Roberts Rules of Order, the by-laws supersede the Standing Rules. She says you need to change the by-laws before you can change the Standing Rules. Discussion followed as to whether we can make this change to the Standing Rules even though the By-Laws may be in conflict. That was never really determined and will be dealt with during the by-laws review in July. When the Standing Rule was made in the last review, the intention was to charge extra for the mail delivery, but it was not worded correctly so they could not change the dues for those receiving it via mail. It was suggested we make a motion to change the by-laws and postpone the vote until next month, but it was not considered.

The vote was taken by polling each member. The vote was Yes -31, No -4. Motion was passed.

The meeting was called to order at 4:30 p.m. Kathy Greene, President presiding, Corinne Gurney as Secretary. We meet via Zoom.

#### **Approvals**

The minutes for the March meeting was moved for acceptance as entered in the April newsletter. Per new SCCQG parliamentary procedure, we only need to ask for discussion; if none, passed as written.

#### 1st VP Programs/Nette Louton

We have a speaker, Jane Hauprich, next month. She will be discussing how to quilt your quilt. In June, we will have Teresa Duyera Wong talking about Japanese quilts.

She went to meet the teachers on Saturday. A lot of them are still doing it virtually, so we don't have to pay for them to come. They are running about \$300 to \$400. Some have workshops that last for 3 to 4 hours. She may sign up some to get us back into doing that.

We discussed about letting members sign up for virtual workshops that different teachers are offering, and the guild would help pay for it. There are some great ones being offered. She will look more into it. Do we want to continue making phone calls? This is not part of our job, so what do people think of it? It was discussed, and it was determined that it is a good thing, so she will keep sending out lists to call. If someone can make time for it, do what we can. Let Kathy Greene know if you cannot make the calls.

She would like to start listing virtual quilt shows in the newsletter.

#### 2<sup>nd</sup> VP Quilt Show/Jamie Harrington

We had 3 vendors now want to come back to our show next year. They had been with us in the past. She will be passing the tickets for the Jazz2 to Donna Roberts for her to sell. All the tickets have had the date updated on them. We need to update the flyers with the new dates.

#### Treasurer's Report/Stephanie Shuping

She sent the reports out. The only income this month is from the door prize tickets. There are questions about how doing basket raffles applies to our gambling license rules. This needs to be researched.

### **Secretary's Report/Corinne Gurney**

She made a statement about the issues brought up about the last general meeting minutes. She stated that she had asked for clarification from 2 people as to what should be in the minutes. One person did not respond, so that is why they were written the way they were.

She asked that people do respond to her email requests so that information can be accurate. She

preps for each meeting so that she can do the best she can to take notes and keep up with everything. It is helpful to have as much information beforehand, so she can do a better job.

#### Peggy Vachon/Newsletter

She is trying to make sure newsletters emailed do not go into spam. She is creating an email account that is just to send out the newsletter. She also wants to make sure spam emails are not being sent out to members using her email address. Hopefully the new address will stop this. If you do not receive your newsletter, please check your spam folder.

#### **Old/New Business/Kathy Greene**

She would like to hold the next board meeting in her backyard on May 18<sup>th</sup>. Corinne will be in Seattle that day. Nette volunteered to take notes. Stephanie will not be able to attend physically either. Peggy cannot attend if it is at 4 p.m. We can Zoom everybody for those who cannot physically attend. It was decided to keep it a Zoom meeting.

The June board meeting is the rollover. The budget will also need to be presented for the next fiscal year. The board meeting would be June 15, general meeting is the 11<sup>th</sup>. She hopes to be able to do the board meeting at a restaurant. A budget planning meeting was set up for May 19<sup>th</sup> via Zoom at 2 p.m. The only people who need to be there are the President, both VP's and the treasurer.

Our bylaws said we were supposed to have voted this month on the next slate of officers. Lynell and Peggy Campbell said no to the positions they had been asked to do. 
