students succeed at completing a challenging project. Another is seeing students have "Aha!" moments during which they see how simple changes in construction technique can help them create projects that look better while taking less effort.

Hexagons: Six Sides, One Angle, and Oh So Many Possibilities

The hexagon is successfully used in both traditional and contemporary quilts. The unique six-sided geometry of the hexagon makes it exceptionally versatile! While hexagons can be arranged in interesting patterns, they can also be created from other shapes, such as triangles and diamonds. Quilted hexagon pieces can incorporate many techniques, including machine piecing, hand piecing, English Paper Piecing (by hand or machine), fussy cutting, embroidery, and quilting.

Greeting/President Roberts: Welcome! Please make sure you are signed up for Show and Share. We may be in the big room next month.

Nette Louton introduced the speaker, Nanette Zeller, who presented her lecture, "Naturescapes,". via Zoom. You can see her article, "Faux Float Frames," in *Quilting Arts*, Summer 2022. You can also read her weekly blog, sign up for her newsletter, and check out her online classes on her website, <u>nanettesewz.com</u>. She also has a YouTube channel.

Minutes: The September meeting was canceled.

Treasurer's Report: Dixie Bahr said the California Justice Dept. has kicked back our raffle permit twice. She is working on submitting the form a third time with answers to all their questions. Until it's approved, we can't sell raffle tickets.

Greeting/President Roberts:

Minutes: Nette Louton moved to accept the September board meeting minutes. Seconded by Kathy Judkins. Motion passed

Programs/1st VP/Nette Louton: November's speaker will be Carol Wilhoit with English Paper Piecing by Machine. The tea in Sept. was canceled due to the heat. Philanthropic/Kathy Judkins: Kathy has taken pictures of all the quilts people have given her and she'll put them on the website. Quilts were donated to the Women's Clinic of AV and other places. Kathy suggested that the guild make gifts (bowl cozies and tote bags) for the people at Harshfield Terrace to thank them for the use of their facilities. Maggie Konik is cutting kits to help with this.
